

**MINUTES– CHEROKEE RIDGE – REGULAR MEETING – AUGUST 8, 2022**

The Town Council of the Town of Cherokee Ridge met in regular session on August 8, 2022 at 7:00 p.m. in the Cherokee Ridge Club House, 4000 Cherokee Ridge Drive, Cherokee Ridge, Alabama.

The meeting was called to order by Mayor Natalie Burke.
