

**MINUTES– CHEROKEE RIDGE – REGULAR MEETING – FEBRUARY 13, 2023**

The Town Council of the Town of Cherokee Ridge met in regular session on February 13, 2023 at 7:00 p.m. in the Cherokee Ridge Club House, 4000 Cherokee Ridge Drive, Cherokee Ridge, Alabama.

The meeting was called to order by Mayor Natalie Burke.

Upon roll call, the following were present: Mayor Natalie Burke; Councilmembers Stephen Britt, Preston Jacobs, Wayne Martin, and Scott Nixon. Absent: Councilmember Russell Bobo. Also present were Town Attorney Alex Smith, and Town Clerk Gail Busbey.

The invocation was given by Gail Busbey. The Pledge of Allegiance was led by Councilmember Jacobs.
