The meeting was called to order by Mayor Natalie Burke.

MOTION by Councilmember Britt and seconded by Councilmember Martin that the minutes of the work session and organization meeting of September 13, 2021 be approved as written. Upon roll call, the following members voted Aye: Mayor Burke, Councilmembers Bobo, Britt, Jacobs, Martin and Nixon. Nays: None. Mayor Burke declared that the minutes of the September 13, 2021 work session and organizational meeting approved as written.

MOTION by Councilmember Martin and seconded by Councilmember Nixon that Mayor Burke be authorized to secure public officials liability insurance and surety bonds at a cost not to exceed \$2,500.
